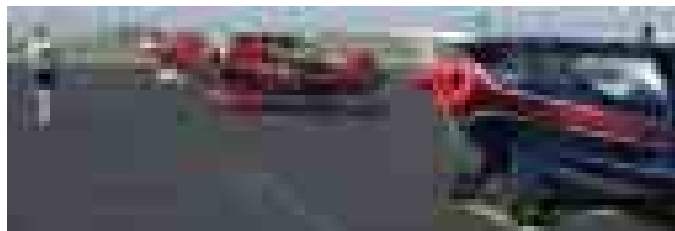

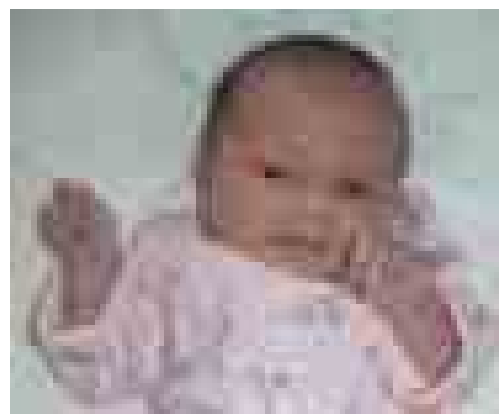

I spoke with Rod Buchannon earlier this week and apparently the City of Tracy is attempting to make much-needed improvements to the runway. That's the good news. The bad news is that they're waiting for approval for an FAA grant to get this done and Rod was uncertain whether this was a few weeks, or few months, away. He promised to keep us closely in the loop, but until then, we can still use the box but can't land there.

3) Speaking of "box". Angie Niles and Don Gutridge have been doing a stellar job at pursuing the reapproval of our box at Tracy. The short version of the story as it stands right now is that the City of Tracy is still very supportive and is working behind the scenes at the Oakland FSDO to help us get the box back. Angie and Don have redrawn the dimensions of the Box to address all of the FAA's concerns. Unfortunately, the key FAA person we're having to deal with is being extremely difficult and continues to reference one reason after the next as to why he won't reapprove the box, ranging from accusations that we're flying with less than minimum legal fuel reserves, that we're flying over people in the gravel pits, that we're creating too much noise, and then most recently, that housing is encroaching on our box. Bottom line is that we've now addressed all the concerns and it looks like the key step is going to be a requirement that we hold some community outreach events to enable a public forum to debate the box. The Tracy Airport Commission appears to be willing (almost enthusiastic) to take this on and help us get this community support so we'll see how that goes. Angie, Don, and I have a meeting with the Tracy Airport Commission on April 14th to share with them our plan and get their guidance on the best way to move through this. Let's keep our fingers crossed...

4) Lastly, we're planning to have a session on "Maintaining your Aerobic Airplane" at the next Chapter meeting (April 10) so whether you rent or own, you should plan to attend and learn how to watch for things that break, and how to maintain parts of an aerobatic airplane yourself.

I'll send out an email as we get closer to the Chapter meeting, and Allyson's Nut Tree party so we can get as many of you to participate as we can.

In the mean time, blow out the cobwebs and start flying...

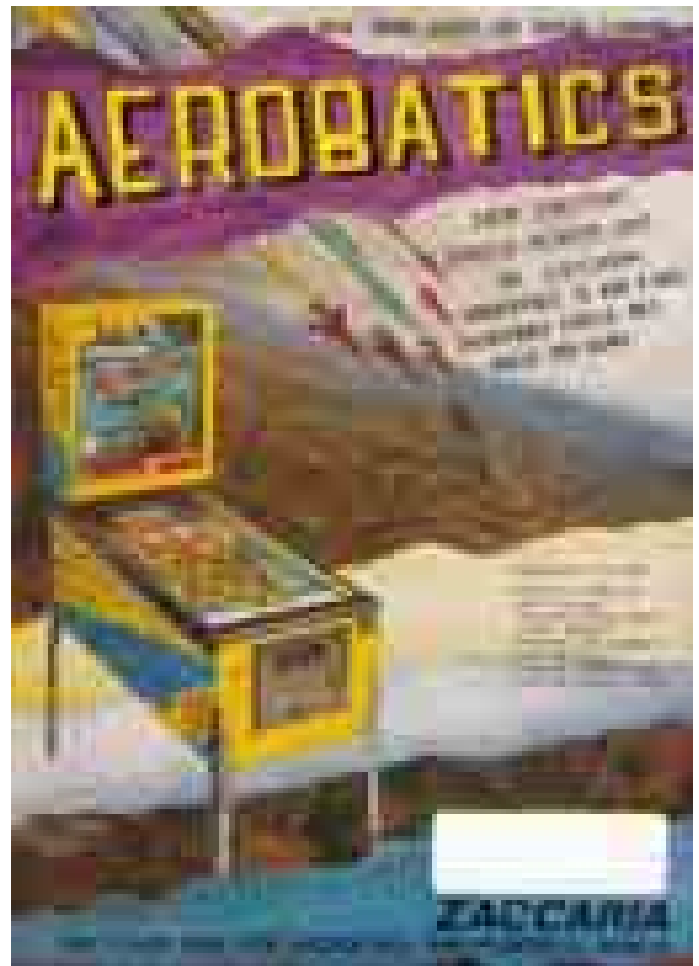

Tracy Box Update

I am continuing to work with the OAK FSDO to try and re-establish some form of the Tracy Box. During this process OAK FSDO has conveyed to me the perception that they feel there is widespread disregard for observing the Minimum Allowable Fuel requirement (30 min fuel reserve) within the aerobatic community. Darren and I have both denied that our chapter condones such a practice and that we know of no one who flies that way. When asked, they were unable to produce documentation for even a single instance but it is, nonetheless, their perception and it apparently had influenced their TCY box renewal decision. I am working with them to dispel that myth; however, that takes time. Part of my effort was to agree to educate the membership via a series of notifications and discussions that FAR 91.151 is NOT WAIVED and box users must adhere to it.

I know of no occasion of people flying with less than the fuel minimums; however, it is absolutely critical that our members comply with FAR 91.151 and plan their flight such that they land with sufficient fuel on board. The OAK FSDO has nothing to base their claim on and it is extremely important to keep it that way. Failure to comply could be used as grounds for waiver revocation. I don't know idea if they are planning to ramp check and I doubt they would divulge that if they were, but you might keep that in the back of your mind.

On another front, we have strong support from the City of Tracy and the Tracy Airport Commission – although that support has been informal and unofficial in the past. We are on the agenda for the next TAC meeting at which time the commission will make a decision as to whether or not to formally support our aerobatic activities based out of the TCY. The result of that decision will be the basis of a recommendation that will be forwarded on to the City of Tracy proper. Formal support of the TAC and the City of Tracy would include their participation in the OAK FSDO TCY box discussions, an outreach effort to the community around the airport to accept aerobatic activity as one of the ongoing operations and, hopefully, reduce noise complaints, as well as assist us in tracking, mitigating and resolving noise issues.

Below is FAR 91.151 obtained from the FAA website.

§ 91.151 Fuel requirements for flight in VFR conditions.

(a) No person may begin a flight in an airplane under VFR conditions unless (considering wind and forecast weather conditions) there is enough fuel to fly to the first point of intended landing and, assuming normal cruising speed—

- (1) During the day, to fly after that for at least 30 minutes; or
- (2) At night, to fly after that for at least 45 minutes.

(b) No person may begin a flight in a rotorcraft under VFR

conditions unless (considering wind and forecast weather conditions) there is enough fuel to fly to the first point of intended landing and, assuming normal cruising speed, to fly after that for at least 20 minutes.

In-Flight Spade Break

By this time I finally clued myself in on a spade problem. I shot a straight in approach to Tracy from 5,000 feet and landed with no problems.

When I got out of the plane I found that the weld on the leading edge of the spade arm had broke. It looked like someone had taken off the front two bolts of the spade and bent the spade back 180 degrees around the rear two bolts. In this case, the front two bolts were dutifully hanging on to the piece of the spade arm forward of the weld. When the weld broke, the spade caught the wind stream and bent back 180 degrees parallel with the wind, causing the stick to snap to the left and back in an instant. No big deal and no uncontrolled rolls in this case.

Further inspection of the break revealed a thin shiny line of newly exposed aluminum lengthwise along the break. The rest of the thickness of the metal showed a corroded brown color indicating that a crack along the edge of the weld had existed for awhile. A set of new spades and new arms put us back into business and we didn't miss one New J session!

Fly safe!

If anyone is wondering what happens when the leading edge weld of a spade arm gives way then read on.

This mishap occurred while I was in a dive at the beginning of a practice sequence. I was at about 5,000 feet or so passing through 170 mph or so in a Pitts S2A. I started three wing rocks to the left and on the beginning of the third one the stick snapped out of my hand to a full left deflection then back in an instant. My first thought was that I had hit some type of wake turbulence, perhaps had a bird strike, and that this was going to make for a great IAC Chapter 38 newsletter article.

As I pulled out of the dive the aircraft was holding trim perfectly and showed no abnormal behavior. I noticed something wrong, however, when I rolled. There was an unusually high amount of resistance when the stick was deflected left and not as much resistance with right aileron input. Strange. My next thought was that something was catching the flight controls, such as a loose seatbelt from the front cockpit.

By this time I was climbing even higher and headed towards Tracy airport with the idea in the back of my mind that flight control malfunctions equate to bailing out. The newsletter article seemed to be getting better by the minute. I then did a level speed change to check for controllability in the landing configuration. The resistance in the ailerons changed with speed but the aircraft did not do anything funny when slow.

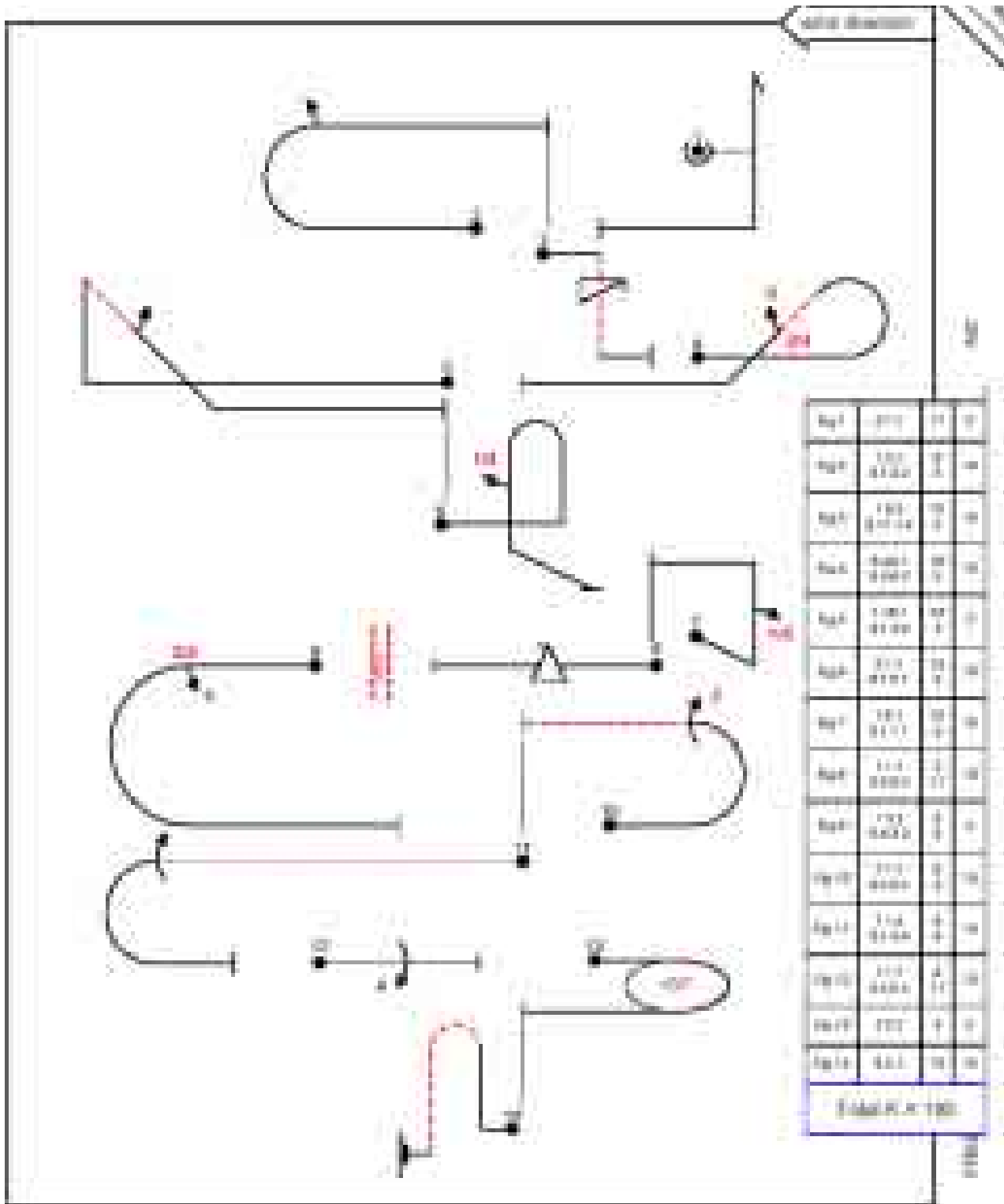
2005 IAC38 Intermediate Free
